Attached please find an excerpt of an empirical study I recently completed. It tests the hypothesis:

Fathers and mothers of minor children receive the same physical-custody, visitation and child-support awards on the date of their Arlington Circuit Court divorce decree in the relevant period.

The results of the study overwhelmingly rebut its hypothesis.

The study made use of the facts that:

- a) each divorce decree in Virginia is made by a Circuit Court,
- b) divorce decrees are public information and well-indexed,
- c) court orders affecting child-custody and child-support are statutorily required to contain certain information, and
- d) each divorce decree is recorded and available to the public from the Bureau of Vital Statistics in Richmond.

The attached results are based on certain assumptions referenced herein. Individual case files in the court clerk's office were not examined. At best, the data reflect what existed on the date of the divorce decree. Lack of full information in a divorce decree sometimes removed cases from consideration, to the extent mentioned herein. Subsequent court orders have, as of today, modified many of the divorce decrees.¹

Sixty pages of handwritten case excerpts have been omitted for brevity. Likewise, a twenty-two-page chart summary of the handwritten excerpts, referred to herein as Exhibit A2, has been omitted for brevity. Interestingly, the excerpt of a study done by the Virginia Department of Child Support Enforcement refers to child-support payors as "fathers" and to payees as "mothers."

¹ In contested custody cases, Arlington County judges often quietly bifurcate the case, entering a divorce decree after a property settlement or property adjudication, leaving issues of child-custody and child-support for later adjudication. Custody and support of children can be modified for many other reasons.

**STATISTICAL EVIDENCE OF GENDER DISCRIMINATION AGAINST
MALES IN ARLINGTON COUNTY DIVORCE DECREES CONCERNING
CHILD-PHYSICAL-CUSTODY AND CHILD-SUPPORT OF MINOR CHILDREN**

I. Preface:

The following conclusions are based only on the explicit terms of Arlington County Divorce Decree Orders officially recorded between July 1, 1989 and Dec. 31, 1990, a one and one-half year period. As such, each data point represents only one point in time for each case, and may have been modified, limited, or made not available by another order not able to be covered by this survey.

Each conclusion is based on the summary data of of Exhibit A1, which is based on the summary data of Exhibit A2, which is based on the summary data of Exhibit A3, a list of each divorce decree issued by Arlington County in the relevant period by the Virginia Bureau of Vital Statistics, as supplemented by use of official Arlington County Chancery Order Books and official Arlington cross-reference files.

The validity of these conclusions is directly affected by the assumptions and data-computation procedures mentioned in Sec. V. herein. Only cases meeting the eligibility requirements have been considered, e.g., minor children, explicitly mentioned child-custody, etc..

II. Conclusions:

A. Child-Custody

In Arlington County Divorce Decrees awarded between July 1, 1989 and Dec. 31, 1990, NO FATHER was given ANY PHYSICAL-CUSTODY of ANY of his child(ren), UNLESS the mother had agreed, theretofore, to the same.

Only 19 fathers out of 232 (8.2%) were permitted ANY amount of explicit PHYSICAL CUSTODY (excluding mere visits/visitation) of their children, and then ONLY with the FULL CONSENT OF THE MOTHER.

Excluding the fathers who received SOME/ANY PHYSICAL CUSTODY of their children, only 32 fathers out of 232 (13.8%) explicitly received ANY AMOUNT OF CHILD VISITATION.

The great majority of fathers (190 fathers in 232 cases, 82.3%) received NO EXPLICIT AMOUNT OF EITHER PHYSICAL CUSTODY OR VISITATION of any of their minor children.

Mothers received the PHYSICAL CUSTODY of almost ALL (351.5 out of 379 minor children, 88.5%) of their minor children, TO THE EXCLUSION OF THE FATHERS of the children.

Mothers have received "visitation" rights for 12 kids out of the 27.5 kids (43.6%) in the physical custody of their fathers, but fathers received visitation rights for only 51 kids out of 351.5 kids (14.5%) in the physical custody of their mothers.

Thus, the super-majority of fathers in Arlington County has had no substantial and legally-enforceable means of visiting with and sharing in the parenting of its children, and has been essentially dispossessed of its children by Arlington County.

B. Child-Support

Fathers were ordered to pay some amount of child-support in 163 cases out of 168 cases, 97%.

Mothers were ordered to pay some amount of child-support in 5 cases out of 168 cases, 3%.

The aggregate total monthly child-support payable by fathers is \$82,876/mo., out of the total monthly child-support made payable by court orders, \$84,426/mo., 98.2%. Mothers pay only 1.8% of that.

The great bulk of Arlington County Child-Support Enforcement has been directed against the fathers of children, because they are fathers, i.e., males, rather than because they are parents.

III. Sources of Information:

- 1) Virginia Bureau of Vital Statistics, Richmond, Va.
- 2) Arlington County Circuit Court Chancery Order Books
- 3) Arlington County Case Cross Indices

IV. Outline of Investigation:

The Bureau of Vital Statistics provided a list of each and every divorce decree in which there were children under age eighteen over an eighteen-month period, July 1, 1989 through December 31, 1990 in Arlington County. The Bureau derived its information from official VS-4 forms provided by Arlington County Chancery Clerks and input into its computerized data base. There were 383 cases received from Richmond, about 40% of which were removed from consideration completely, due to lack of any relevant information in the divorce decree order itself.

The cases from Richmond were listed in order of divorce decree, and contained, inter alia, the name of each husband and each wife. Via use of the Arlington County Cross Indices, the docket number of the case and the book and page number (in the Chancery Order Book) of each divorce decree was obtained. Each order was individually examined in the Order Book, and notes were taken on each order. The conclusions were computed from the notes and orders.

V. Procedural Computation Matters

- * A Divorce Decree Order in which there were no children, or only adult/emancipated children, was not considered, except to the extent that there remained at least one minor child. Where there were both adult and minor children, only the minor children were considered.
- * A Divorce Decree Order in which there was no mention of either child-custody or child-support matters was not considered. An Order in which all was settled by an out-of-court agreement, but no terms of the agreement were stated or summarized in the Divorce Decree Order, was not considered.
- * A Divorce Decree Order in which there was mention of child-custody and/or visitation, but no mention of child-support, was considered only on the matters explicitly mentioned. Only child-support which was regular and quantified was considered.
- * If visitation or physical-custody or child-support was mentioned in the Divorce Decree Order for one parent, but not mentioned in the Order for the other parent, the latter's share is deemed to be zero, since it was not important enough to be put into the Order.
- * If the court did not have jurisdiction over one parent or the children (e.g., child with father in the Phillipines), the order was not considered.
- * For orders in which there was a "primary physical-custody" award to one parent, but NO physical-custody EXPLICITLY awarded to the other parent, the physical-custody was deemed to be solely in the primarily-custodial parent, since no other physical-custody award was important enough to be put into the order.
- * A temporary child-support award was ignored if there was a permanent or continuing child-support award.
- * An child-support award unquantified (e.g., parent carries child on his medical insurance plan) in the Divorce Decree Order was not considered.

* A purported child-support understanding not explicitly stated (e.g., mother pays for the child's day-care) in the order was not considered, unless explicitly stated and quantified, since there is no court-ordered duty to do so.

* Child-custody or child-support orders prior to or subsequent to those of the divorce decree order were not considered.

* For the purposes of ease in computation, joint-physical-custody of a child was deemed to be 50% per parent unless specifically stated to the contrary.

COMMENTS ON JULY 1989 - DECEMBER 1990 DIVORCE DATA FOR ARLINGTON COUNTY
REQUESTED BY WILLIAM DOLAN

A listing of the divorces granted in Arlington County on or after 1 July 1989 in which one or more children under the age of 18 were involved was requested in communications of 3 May 1991 and 28 May 1991. The requested information as to whether or not custody of the children was adjudicated could not be provided since this information is not recorded in the Vital Statistics records of the Commonwealth of Virginia. Neither is the Court File Number of the divorce.

The requested records were located and the data fields desired from them were extracted and downloaded to a personal computer from which the data are available on a 5.25 inch diskette if necessary. There are 383 records with a logical record length of 100. They have been retrieved into this document and adjusted for monthly spacing. The records were sorted by date of the decree and then alphabetically by name of the husband for records of the same date. The positions of the data in each of the records has been made to conform to the following. Spaces have been left between fields for ease of reading. Missing values are indicated by a dot in the field.

A dot in the Custody fields indicates that the field was not coded on the record but simply left blank. This occurred on all of the records for 1989. The coding is 0 to 7 for children up to 7, 8 for 8 or more children, and 9 if the number is unknown. The majority of the records for 1990 were coded with 9's in the custody fields.
